- -1 gestionnaire pour assurer le suivi financier (paiement des bourses, bilan financier)
- -1 personnel de direction pour coordonner le B.R.I. et veiller au respect des engagements notamment en matière de communication et de mise à disposition des divers documents obligatoires via le site internet

# **Evaluation Summary Report**

#### Criterion 1 - Relevance of the Erasmus Policy Statement (EPS)

Status: Yes

The detailed criteria are set out in the call conditions (see Call document).

The applicant presents an Erasmus Policy Statement (EPS) in line with the institution's profile. The EPS is consistent with the mobility activities that the institution intends to undertake.

The institution mentions also the willingness to participate in Programme activities. It is recommended that the applicant carefully reads the Charter guidelines to learn more about the other opportunities offered by the Erasmus+ Programme in case they decide to extend their participation to other Programme activities.

The institution should contact their Erasmus + National Agency if they decide to modify their EPS.

#### Criterion 2 - Quality of organisation and management

Status: Yes

The institution demonstrates that it has the capacity to implement the planned activities and to ensure their sustainability. The measures for guaranteeing the visibility of Erasmus+ opportunities are satisfactory.

## Criterion 3 - Implementation of the ECHE Charter principles

Status: Yes

The detailed criteria are set out in the call conditions (see Call document).

The institution commits to implement full automatic recognition and describes some of the steps to take.

However, they should improve their practices by carefully reading Council Recommendation of 26 November 2018 on promoting automatic mutual recognition" to improve their methodology in line with the Council recommendation.

Further to the measures to implement full automatic recognition, the institution should ensure full transparency towards students, and include a clear procedure for appeal.

The application describes adequate procedures for staff recognition when it comes to participation in mobility.

The application commits to ensure a fair and equitable treatment to all students, and has a general strategy in place to ensure this. However, they do not explicitly mention the selection procedure to be implemented for the participation in the Erasmus + Programme activities. The institution should also consider the possibility of creating training / information activities for staff and students to ensure full and equitable access to participants from all backgrounds.

The applicant shows commitment to implement the European Student Card Initiative and promote the use of Erasmus+ Mobile App. The applicant should improve their knowledge about these two initiatives.

They should also ensure that the institutional information is present and up-to-date in the E+ mobile App.

They should also devise a promotion campaign for these initiatives in their institution.

The institution demonstrates that they intend to promote and implement environmentally friendly practices. The examples given are not very numerous, but are appropriate and in line with the new principles of the ECHE but the institution should also promote sustainable means of travel. The measures are not described in the context of the participation in the Erasmus+ Programme.

The activities proposed are relevant to promote civic engagement and active citizenship amongst the participants in mobility activities.
